PROPOSED CONSENT ORDER

Account No. 350

Pursuant to the provisions of the Alabama Environmental Management Act, Ala. Code §§22-22A-1 to 22-22A-16 (2006 Rplc. Vol.), the Alabama Department of Environmental Management is proposing to issue a Consent Order to SABIC Innovative Plastics US LLC, the owner/operator of a chemical manufacturing production facility currently operating in Burkville, Lowndes County, Alabama.

The violations consisted of failure to properly conduct a Leak Detection and Repair Program and failure to properly report deviations of the Leak Detection and Repair Program.

The Department is proposing a civil penalty in the amount of \$200,000. The order, if issued, would require SABIC to comply with all requirements of ADEM Administrative Code div. 335-3 and Major Source Operating Permit No. 207-0008 immediately upon the effective date of this Order and continuing each and every day thereafter.

Interested persons may submit written comments, including request for a hearing, within 30 days of the publication date of this notice, to:
