**FINDING OF NO SIGNIFICANT IMPACT Town of Hayneville Lowndes County DWSRF#: FS010127-03**

The Alabama Department of Environmental Management has made \$790,000 in financial assistance available to the Town of Hayneville using funds from the FY 2012 Drinking Water State Revolving Fund (DWSRF) loan program. In accordance with State and Federal regulations that govern the program, the Alabama Department of Environmental Management has conducted a review to assess the potential impacts upon the environment that may result from implementation of these drinking wa-

ter improvements.

The Town of Hayneville proposes the construction of a 250 GPM potable water well to replace the existing inactive Well No. 1. The proposed project will consist of a new test well, a permanent protection well, well housing, piping, and a generator with controls and telemetry. Currently the system utilizes Well No. 2 which operates at 24 hours per day during peak periods and two interconnections with adjacent water systems that provide a limited amount of water supply for the system. Completion of this project will provide much needed additional capacity, reduce pumping demand for the existing Well No. 2 thus eliminating potential water outages for the customers of Hayneville.

The Alabama Department of Environmental Management has determined that the project will not have a significant adverse impact of the environment and consequently is herewith issuing a Finding of No Significant Impact (FONSI) to support the use of DWSRF funds for the construction of the proposed project. However, this de-

termination may be reconsidered if significant adverse information concerning the potential environmental impacts of the proposed project is discovered. Attached is an Environmental Assessment that details the proposed project and its impact upon the environment.

Comments relative to these projects should be submitted in writing to Ms. Asia Stephens, SRF and Operator Certification Section, Permit and Services Division, Alabama Department of Environmental Management, P.O. Box 301463, Montgomery, Alabama 36130 no later than 30 days after the date of this FONSI. The Department will not take formal action to proceed with the proposed projects without carefully evaluating any public comments concerning funding of the proposed projects.
